### Highlights of Rules and Regulation - Boy's Hostel

1. The last entry time for students in the hostel will be **09:00 PM**. If any student arrives after **09:00 PM**, they must provide a written explanation to the **Dean Student Welfare Office** the next day.
2. The **Hostel Mess** will close at **09:00 PM**.
3. Students must turn off lights and fans when not in their rooms; otherwise, a fine will be imposed.
4. The use of **high-power music systems, heavy electrical appliances** (such as heaters, induction stove, iron box etc.) is strictly prohibited.
5. Before leaving the hostel for home, students must obtain permission from the **Warden** and submit an application. The application must include their **room number, phone number, parent's phone number, and the complete address of the place** they are visiting.
6. If students do not return to the hostel on time after the designated holidays, the **Hostel Warden** will inform the **Dean Student Welfare**, and disciplinary action will be taken against the student.
7. **Visitors** (parents/guardians) are allowed to meet students only in the **Visitor Room** for a maximum of **2 hours**. Visitors are not permitted to enter or stay in students' rooms.
8. Students are not allowed to **bring food from outside** or **eat meals inside their rooms**.
9. No student is allowed to stay or visit another student's hostel room. If found violating this rule, action will be taken against the **hostel resident** by the **Dean Student Welfare**.
10. Students must wear **decent and appropriate clothing** inside the hostel and mess. Indecent attire in the mess is strictly prohibited.
11. Students must maintain a **healthy environment** in the hostel; avoid **misconduct, fights, or conflicts** within or outside the hostel.
12. Hostel residents are expected to maintain a **calm, peaceful, and clean environment**.
13. Students are **responsible for the safety of their belongings**. The hostel administration will not be responsible for any loss or damage.
14. **Alcohol, tobacco, cigarettes, pan masala, and other intoxicating substances** are strictly prohibited. If found in possession of such items, **strict action** will be taken against the student.
15. Students are responsible for **maintaining hostel furniture** and ensuring the safety of hostel property in their rooms. Any damages will be recovered **individually or collectively** from students.
16. **Celebrations and events** of any kind are strictly prohibited in the hostel premises.
17. If the **college is open and classes are being conducted**, students **must not stay in the hostel during class hours**.

18. In special circumstances, if a student is delayed at night, the final permissible entry time is **10:00 PM**, with prior **permission from the Warden** and necessary communication with their **parents**.
19. Students must sign the **Attendance Register** in the presence of the Warden **every day**.
20. Hostel residents must **regularly check** the **notice board** for important updates.
21. Students are strictly prohibited from keeping **flammable substances, weapons, or toxic materials**. If found in possession of such items, **strict disciplinary action** will be taken.
22. **Parents/guardians** must obtain **Warden's permission** before meeting their ward in the hostel.
23. Students are advised **not to keep a large amount of cash** with them. The hostel administration will not be responsible for any **loss or theft**.
24. Students are expected to maintain **discipline and cooperation** at all times.
